

Steps to Register as an Exhibitor

1. Go to Home Page of the Official Website of the AEROINDIA 2025 : www.aeroindia.gov.in.
2. Click on the “Registration” option available on the menu bar at the top-right corner of the webpage (if you’re on the Desktop mode) and choose the “Exhibitor” option from the drop-down menu. Now, you’ll be redirected to the “Sign Up Your User Account” webpage - “Account” section. (Screenshot at Slide 3)

Steps to Register as an Exhibitor

- **On the “Sign Up Your User Account” Webpage - “Account” Section :-**
3. In the “Account” section, select / fill / upload (as applicable) your Account Information details from / in the options / space provided against each field.
 4. If you are a Company registered in India (as defined under the Companies Act, 2013) and shall be promoting / displaying Defence Products manufactured in India, select “Indian Exhibitor” option against the “Are you?” field.
 5. If you are a Company promoting / displaying Defence Products or Technology manufactured outside India, select “Foreign Exhibitor” option against the “Are you?” field.

Steps to Register as an Exhibitor

- **Steps applicable only for the “Indian Exhibitor” :-**
 - i. Select the Name of your State from the drop-down menu against the “State Name” field.
 - ii. Enter your First Name and Last Name in the designated spaces provided under the “Name of the Nodal Officer” field.
 - iii. If you’re an MSME (Micro, Small and Medium Enterprise), select “Yes” option against the “MSME” field, select the relevant option from the drop-down menu under the “Udyog Aadhaar Memorandum Number / Udyam Registration Number” field, enter your Company’s Udyog Aadhaar Memorandum (UAM) Number / Udyam Registration Number in the space provided under the “UAM / Udyam Registration Number” field, select “Yes” option provided under the “Confirm MSME Certificate is Self Certified” field and upload your Company’s Udyog Aadhaar Registration Certificate in the “Udyog Aadhaar Registration Certificate” field. The file containing the Certificate should be in JPG, PNG or PDF format only and the file size should be less than 2 MB.
 - iv. If you’re not an MSME (Micro, Small and Medium Enterprise), select “No” option against the “MSME” field.
 - v. Upload GST File of your Company in the “GST of the Company” field. The file should be in PDF format only and the file size should be less than 2 MB.
 - vi. Upload PAN File of your Company in the “PAN of the Company” field. The file should be in PDF format only and the file size should be less than 2 MB.

Steps to Register as an Exhibitor

- **If you're an Indian Exhibitor -**

Fill your Account Information in the given fields, enter Captcha and Click on the “Next Step” button (highlighted in Red Box here).

Steps to Register as an Exhibitor

6. Fill Billing Address of your Company in the space provided under the “Billing Address of the Company” field.
7. Enter Name of your Company in the space provided under the “Company Name” field.
8. Enter Contact Email of your Company in the space provided under the “Contact Email” field.
9. Enter Contact Number of your Company in the space provided under the “Contact Number” field.
10. In the “Account Details (for any refunds, if due)” section, Enter the Beneficiary Name, Bank Name, Bank Account No., Bank Address and IFSC/IBAN No. in the spaces provided under their respective fields and upload a Copy of Cancelled Cheque in the “Copy of Cancelled Cheque” field. The file should be in PDF format only and the file size should be less than 2 MB.
11. Enter and Confirm your Password for Login in the designated spaces provided under the “Password” field.
[NOTE :- While composing your Password, follow the Website Password Policy : your Password must be at least 8 characters long and should contain at least 1 lowercase letter, 1 uppercase letter, 1 numeric character and 1 special character (@,#-_/= etc.).]
12. Enter Captcha in the space provided under the “Captcha” field and click on the “Next Step” button.
13. All fields marked with an asterisk (*) are mandatory to be filled.
14. After clicking on the “Next Step” button, you’ll be redirected to the “Sign Up Your User Account” webpage - “Payment” section.

Steps to Register as an Exhibitor

➤ **On the “Sign Up Your User Account” Webpage - “Payment” Section :-**

15. In the “Payment” section, select the preferred Payment Gateway and pay the applicable Exhibitor Registration Fee

➤ **Registration payment for**

- Indian Exhibitors: Can be done while registering using online mode. SBI payment Gateway and Razorpay payment gateway is available for Indian Exhibitors.
- Foreign Exhibitors: Can be done while registering using online mode. SBI International payment Gateway, Razorpay payment gateway and payment through SWIFT is available for Foreign Exhibitors.

➤ **Payment**

- After Clicking desired Gateway, Exhibitor must fill mandatory details.
- Exhibitor must choose further payment method such as UPI/Credit Card/ Debit Card etc. and do the payment.

16. After successful payment of the Registration Fee, you'll receive a Registration Confirmation Email on the Email ID you have provided in the “Contact Email” field on the “Sign Up Your User Account” webpage - “Account” section.

17. After receiving the Registration Confirmation Email, you can login as an Exhibitor by entering your Login Credentials on the Login Page : www.aeroindia.gov.in/aeroindia.

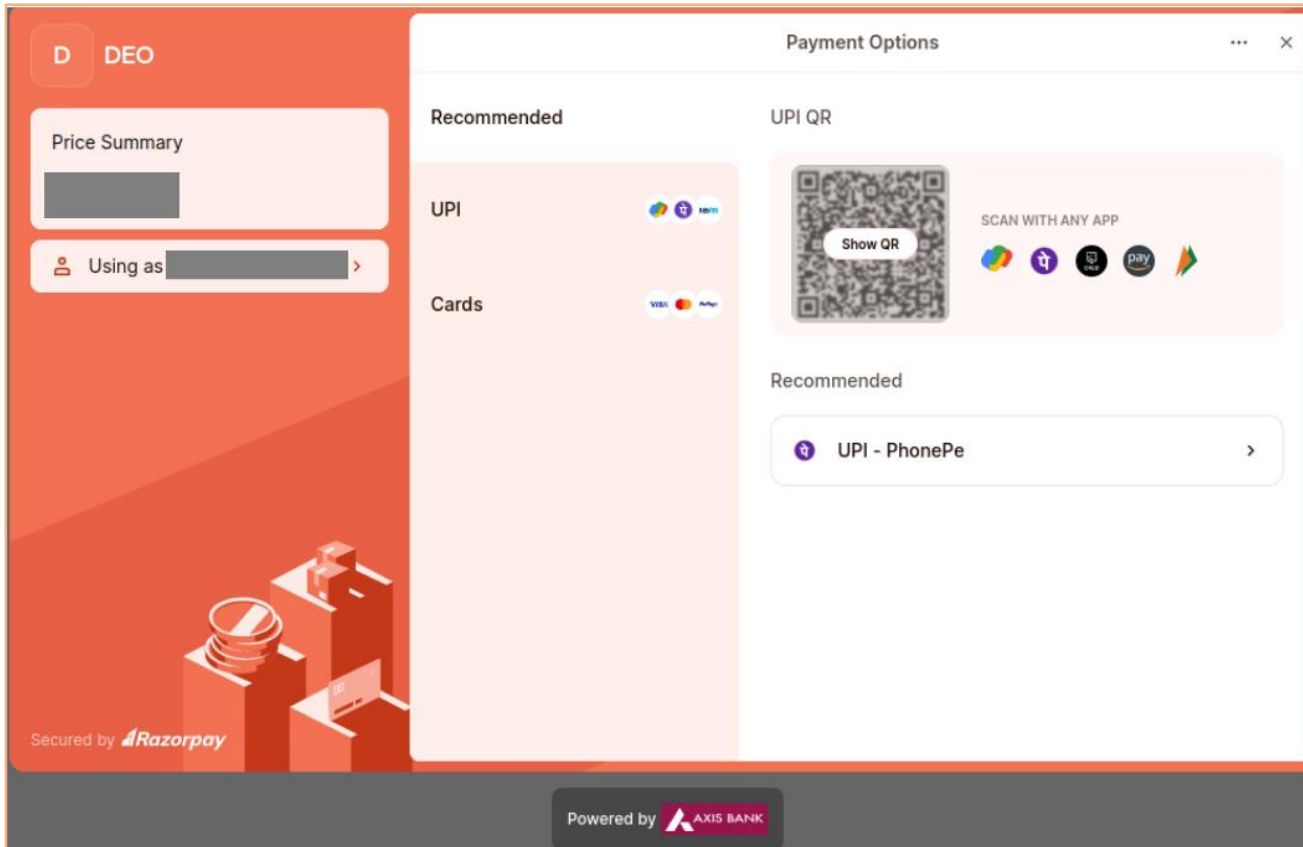

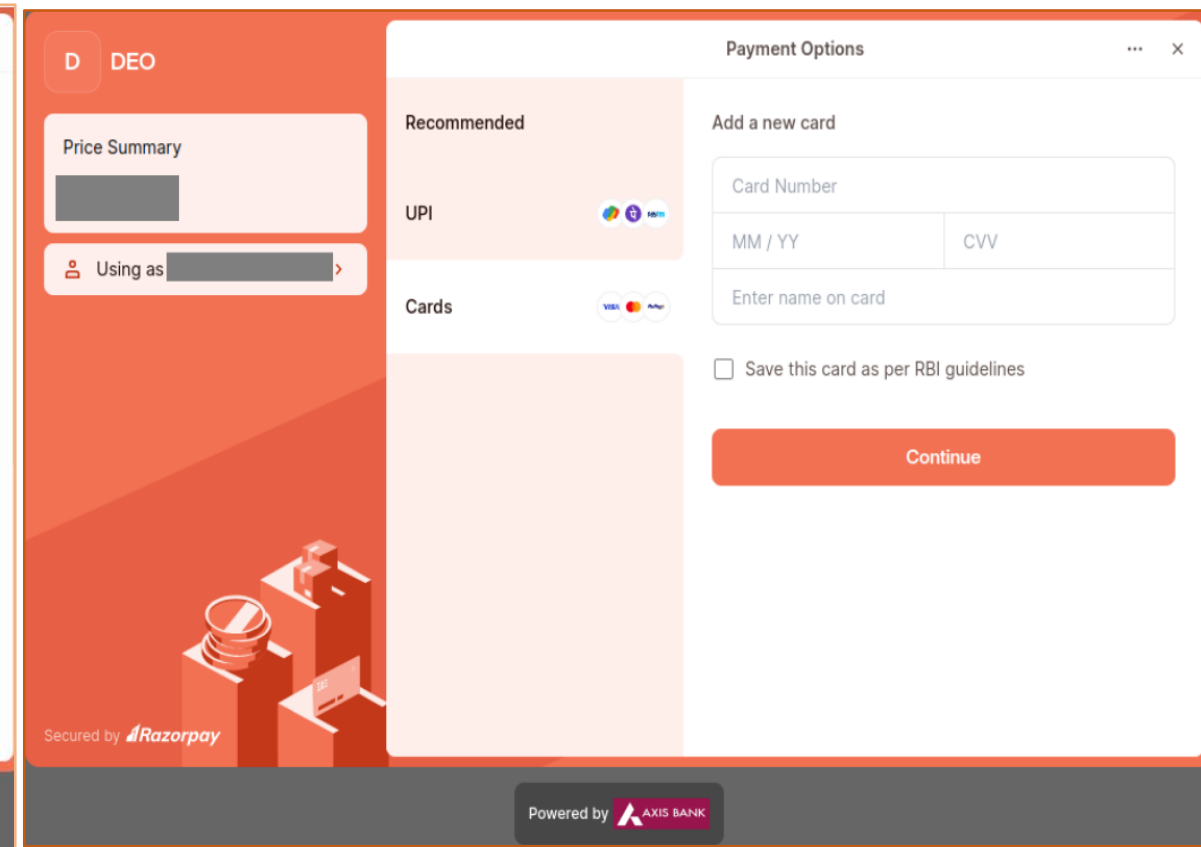
